This document relates to the Regulation for Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006. The regulation entered into force on 1st June 2007 to streamline and improve the former legislative framework on chemicals of the European Union (EU), and places greater responsibility on industry to manage the risks that chemicals may pose to the health and the environment.

UNIPOWER LLC is a leader in high-density, low profile and hot swap power solutions for telecoms, datacoms, network equipment, servers, data storage, industrial and medical systems. These products are considered as "articles" and therefore Unipower fulfills the role of article supplier. As such, Unipower LLC has an obligation to report the presence of any Substances of Very High Concern (SVHC) in a concentration above 0.1% by weight in articles we produce, import, or distribute within the EU market.

Pursuant to **ECHA/PR/20/02 of January 16th 2020, including all previous amendments**, the European Chemicals Agency (ECHA) expanded the total number of Substances of Very High Concern (SVHC) on the Candidate List to **205 substances**. The status of the Candidate List will continue to be monitored, and Unipower LLC shall inform customers if any article contains more than 0.1% by weight per article of any substance that is included in the SVHC candidate list. As of the date of this declaration, UNIPOWER LLC, has no knowledge of the presence of any Substances of Very High Concern (SVHC) in a concentration above 0.1% (w/w), except as indicated otherwise, for the product indicated above. Additionally, Unipower LLC affirms that the product does not include any substances in the REACH Authorization List (Annex XIV of the REACH Directive), nor any substances in the REACH Restriction List (Annex XVII of the REACH Directive), except for those substances for which an exemption is applicable and within the full scope of the Conditions of Restriction.
